### Minutes of Faculty Council Meeting 3.10.11

### Dean's remarks:

- President's Research Fund: CAS had 8 funded, School of Medicine had 11. Next round submissions will focus on collaborations across colleges.
- Dean search decision will be made by late March early April. Committee meeting and deliberating, will meet with Vice President Patankar.
- UAC Budget starts in Fall. New undergraduate programs requiring financial resources must be submitted in March for VP approval in May and budgeting in fall.
- Evaluations committees for teaching, service, research; members have been named: Teaching - 4/12 members are from CAS Research productivity – 3/12 from CAS Service – 1/12 from CAS Leadership 3/12 from CAS
- STEM+ Father Biondi has hired an architect, and we have been given permission to submit a grant proposal.

## Minutes from last meeting – vote to accept – seconded, approved.

### **Committee Reports:**

Technology committee:

- 1) flux in ITS leadership
- 2) backup storage moving to a new backup storage system; old was \$10-14,000/terabyte; new one is \$6000/terabyte; includes backup to tape, but only holds for 31 days. Not clear how much backup we currently have. There's no indication of any backup storage since Jan 1, 2011.
- 3) Departmental websites: ITS person will not be continuing after graduation, so no help to departments with websites
- 4) We continue to have more HP hard drive failures.

# Board of Graduate Education:

# • Move to consider revision to article IV:

Article IV: Approvals

A simple majority vote of a quorum of the members present (including the Chair) is needed for approvals. All BGE approvals are submitted to the Faculty Council for approval before being moving on to the Dean for final CAS approval. New courses and programmatic/curricular changes limited to CAS are then implemented. New programs and policy/procedure changes are submitted to the Associate Vice President for Graduate Education for further approval by the Graduate Academic Affairs Committee and, in the case of a new program, to the VP Frost Campus and the Board of Trustees.

Motion seconded. All in favor, motion passes.

- Motions to change bylaws:
  - 1) Motion to change name of Curriculum Committee to Undergraduate Curriculum

Committee. Motion (introduced at the November, 2010, Faculty Council Meeting): The by-laws shall be amended to specify that the Curriculum Committee shall handle matters relating to Undergraduate Curriculum.

Proposed changes in italics:

*"Undergraduate* Curriculum Committee:

The *Undergraduate* Curriculum Committee shall consider proposals for additions, alterations, or deletions in the *undergraduate* academic courses, programs, and graduation requirements of the College, and shall be the primary vehicle within the College for *undergraduate* curricula coordination and review."

Vote 19 in favor, 0 not – passes.

2) Motion (introduced at December, 2010 meeting): The Board of Graduate Education shall be established as a standing committee of the Faculty Council, and the following text shall be added to the Faculty Council bylaws with the underlined text deleted: In the section regarding standing committees: The Board of Graduate Education is generally concerned with the development, improvement and quality control of graduate education initiated in the departments and programs of the College of Arts and Sciences. More specifically, the Board reviews and approves proposals for curricular changes, new courses and new programs; reviews and establishes administrative procedures and college-wide academic standards for admissions and for degree, thesis and dissertation requirements of the graduate programs; and advises the Deans on any issues they may bring to the Board. The Chair and members of the Board must have Graduate Faculty status. The Dean and Associate Dean for Graduate Education are non-voting ex-officio members of the Committee. Approvals of the Committee are subject to the approval of the Dean and are reported to the Faculty Council.

Vote - 19 in favor, 2 opposed. - motion passes.

3) Establish Graduate Faculty Membership Committee to be a standing committee. Motion (introduced at the December, 2010, meeting): The Graduate Faculty Membership Committee shall be established as a standing committee of the Faculty Council, and the following text shall be added to the Faculty Council by-laws in the section regarding standing committees: "The Graduate Faculty Membership Committee participates in a concerted effort within the College of Arts and Sciences to bring credibility and visibility to graduation education in the College. As such, it ensures that faculty across the College who teach and mentor graduate students have active research agendas or participate in their profession in a way that warrants their appointment to Graduate Faculty. Within departments, faculty research or professional productivity is best determined by the Department Chair. The Committee's main task is to ensure that departmental standards are being applied consistently across the College. Its secondary task is to hear appeals from faculty members concerning adverse decisions by a department about membership on the Graduate Faculty. The Chair and members of the Committee must have Graduate Faculty status. The Dean and Associate Dean for Graduate Education are non-voting ex-officio members of the Committee. Approvals of the Committee are final and are reported to the Faculty Council."

Vote - pases18 to 2, motion passes.

4) Graduate Faculty Membership Committee – reports to faculty council but doesn't seek approval. Original text must be amended to reflect this fact. Motion to strike the underlined sections of text (introduced at the December, 2010, meeting):

- Original text: Recommendations of the standing committees are brought to the Faculty Council in the form of a motion so that the proposal can be fully discussed and acted upon by the Council. All of the recommendations of Council committees must go to the Faculty Council for approval.
- Amended text: Recommendations of the standing committees are brought to the Faculty Council in the form of a motion so that the proposal can be fully discussed and acted upon by the Council. With the exceptions of the <u>Board of Graduate Education and</u> the Graduate Faculty Membership Committee, all of the recommendations of Council committees must go to the Faculty Council for approval. The <u>Board of Graduate</u> <u>Education and the</u> Graduate Faculty Membership Committee will report recommendations to the Faculty Council, but only amendments to the by-laws of <u>these</u> <u>two</u> committees require Faculty Council approval.

Vote – 19 to 1 in favor, motion passes.

- 5) Vote to change bylaws with current amendments: 18 in favor, none opposed bylaws are changed
- Motion to dissolve adhoc GEC and GMC committees at end of this year. All in favor, none opposed motion passes.

Students in natural sciences might have trouble filling requirements. Though about 100 courses used to be listed under these requirements, only 16-18 were ever offered in a single semester (though could have multiple sections), so not necessarily a large decrease in number of available courses. About a dozen courses still be considered at next meeting, so might be on books by fall; more courses will be added next year.

BS students – need to take courses that do "double duty" (fulfill more than one requirement); students will need good advising to choose these courses. Committee recommendation is to not make any changes to course requirements for BS students.

Issues- these courses won't be offered often enough or in enough sections, or with enough students in each section to accommodate all students needing to take them.

Number of courses is increasing, though, so might be sufficient by the time they're needed.
