PROGRAM OVERVIEW

Students in the Master of Accounting (M.Acc.) program at the Richard A. Chaifetz School of Business at Saint Louis University enhance their professional accounting abilities while developing strong analytical, problem-solving and communication skills. Our accounting graduates have a long history of success on the CPA exam, with pass rates exceeding Missouri, national and AACSB-school averages. Our graduates have also earned the Missouri gold medal on several occasions.

THE CHAIFETZ M.ACC. DIFFERENCE

The M.Acc. program is designed to help students develop strong ethical, techincal and professional accounting proficiency, including in-depth proficiency in general accounting, taxation, and auditing. Students can choose from one of four program concentrations, including a new STEM-certified business analysis and reporting concentration. Through our M.Acc.-specific study abroad program in Madrid, students can complete 20% of the program in just two weeks at Saint Louis University-Madrid, SLU's dedicated campus in Spain. Additionally, students can complete an accounting internship for up to three hours of course credit.

M.Acc. students may complete the program with a specialized capstone course specifically designed to support students in preparing for the CPA exam using the Becker CPA Prep materials. Our graduates have a high job placement rate post-graduation, and have gone on to work for public accounting firms, non-profit entities, government organizations and Fortune 500 companies.
