Medicaid appropriations – record setting

- Medicaid is fully funded for SFY 2023
- Funding for additional needs, including
 - \$85.9 for MMIS & technology updates
 - \$16.4M to process Medicaid applications
 - \$578M to DMH for for provider rate equalization
- Once again, budget language purporting to prevent Planned
 Parenthood from receiving Medicaid funding

• Planned Parenthood v DSS, 602 S.W.3d 201 (Mo. banc 2020)



... Made possible by COVID Medicaid fiscal relief

• FFCA (2020) offered states 6.5% FMAP increase for duration of PHE

• Continuous coverage during PHE

• ARPA (2021) offered newly expanding states **5**% **FMAP increase**

• for non-Medicaid expansion groups for 2 years

MO Medicaid enrollment increased from 825,000 –1.3M

• MO's fiscal relief 3.3 times the cost of additional enrollees

- \$2,925M extra federal dollars from FMAP increases
- \$872M additional spending

Medicaid expansion during legislative session

- Doyle v Tidball, 625 S.W. 3d 459 (Mo. 2021, en banc)
 - Ballot initiative constitutional
 - FY2022 Appropriation bills did not prevent funds from being used for Medicaid expansion



- FY2023 Appropriations include \$2.495 billion for Medicaid expansion
- Efforts to redo Medicaid Expansion via another ballot again stalled (HJR 117, HJR 92, SB 938)

Medicaid expansion implementation rocky

- DSS Stumbles Enrollment challenges
 - 183,000 enrolled in Medicaid expansion
 - 56,000 applications pending
- Federal & State Law: 45 days to process
 - MO average processing time 76 days
 - People waiting since Sept.
- Problems?
- What to watch for?
 - CMS from technical help, to mitigation, to corrective action

Prison Nursery – SB 683

Addresses Social Determinants of Health

- For women with 18 months or less left to serve
- Live with and care for their children
- Lower recidivism
- Improves infant health



Opioids – Preventing Overdose (HB 2162 & 2331)

Permits pharmacists to dispense naltrexone hydrochloride under a statewide standing order or physician collaborative practice agreement



Naltrexone

- 1 of 3 FDA approved drugs to treat opioid use disorders
 - Not a controlled substance; not an opioid, no high
 - Protects against risk of overdose
