#### Courses:

#### Introduction to Legal Studies and Teaching Fellows

Teach and evaluate students in a course designed to introduce the first-year law student to the skills necessary for a successful academic experience in law school, including case reading and briefing, note taking in class, outlining, exam preparation, exam writing, time management, etc. Additionally, oversee and evaluate second and third year Teaching Fellows who run structured study groups to reinforce these skills.

#### Legal Methods

Teach and evaluate students in a course designed to develop the student's ability to apply the analytical process needed to solve legal problems. The course considers the building blocks of legal reasoning within the context of problems that arise in certain first year substantive courses. Specific competencies include analogical and deductive reasoning, application of law to facts, issue spotting and exam taking.

#### Advanced Legal Methodology

Teach and evaluate students in a course designed to reinforce the student's ability to read and synthesize statutes and cases, as well as identify relevant facts, and create legal work products, taught in the context of the Multistate Performance Test.

#### **Advanced Legal Analysis and Strategies**

Teach and evaluate students in a course designed to reinforce bar examination study and

test-taking skills. Work one-on-one with students to evaluate and further develop their study skills and test-taking abilities through the use bar exam exercises and personal meeting time.

#### Workshops and Programs:

#### SLU Law Bar Prep Essay Writing Workshops

Develop a syllabus, deliver a weekly lecture on bar exam preparation, and evaluate students on a weekly performance test or essay writing assignment with individualized feedback.

#### SLU Law Bar Prep Information Sessions and Workshops

Develop and present material on effective bar examination preparation; provide counseling to students and alumni regarding the bar exam application process and effective bar examination preparation; and evaluate and provide feedback to students and alumni on practice bar examination essays and performance tests.

#### SLU Law Gateway to 1L Program

Develop and update Gateway to 1L, an asynchronous program comprised of a series of online modules that provides 1Ls with a common background and understanding of the sources of law, the structure of the American legal system, and what is means to think and read like a lawyer. Gateway to 1L also introduces students to the 1L courses, so students have a better understanding of 1L course content and the relationship of the courses to one another.

#### **SLU Law First Generation Program**

Assist in the development and delivery of SLU Law First Generation Program, which begins with a series of asynchronous online modules for incoming 1L students covering issues such as stereotype threat, imposter syndrome, and isolation, and highlighting the different ways the Academic Resource Center can help 1Ls transition into the law school community. Throughout the academic year, the First Generation Program hosts information sessions and programming geared toward assisting first generation law students in making the transition not just into law school, but also into the legal profession.
