# III. <u>Center for International and Comparative Law Distinguished International Speaker Series and Workshops</u>

The Center regularly offers the Distinguished International Speaker Series, bringing in practitioners, judges, and scholars to speak on relevant international and comparative law issues. Our 2023-2024 speaker series will focus on "Bridge to Practice" and features presentations by a speaker from the United Nations Refugee Agency, as well as in-house counsel and law firm practitioners with an international practice.

CICL also sponsors workshops, such as the 2023 full-day workshop on international refugee law titled, *Refugees at Risk? Or Refugees as an International Risk?* Several speakers participated, including James C. Hathaway, James E. and Sarah A. Degan Professor of Law at the University of Michigan Law School.

## V. <u>Summer Law Program in Madrid and International Summer Internships</u>

Each summer, students have the opportunity to study international and comparative law through the Summer Law Program in Madrid. The program, which has been offered on an annual basis for over 20 years, is held on the Saint Louis University Madrid campus. Students may earn up to six credit hours in courses taught by SLU LAW faculty and Spanish visiting professors. The six-week program includes visits to Spanish law firms and courts including the Constitutional Court and the Supreme Court, as well as cultural activities.

Students also have the opportunity to apply to intern abroad after the Summer Law Program in Madrid. The internships that the Center for International and Comparative Law arranges after the Summer Law Program in Madrid provide students the opportunity to gain meaningful international legal practice experience and to improve their intercultural competency skills. The Center places students at a variety of law firms and non-for-profit organizations around the world. As we tailor the internship search to fit our students' interests, we have found new placements each year.

## VI. Semester Study Abroad/Exchange Programs

Through memoranda of understanding and agreements with various international law schools, J.D. students may study abroad for one semester after their first year of study at SLU LAW. We offer semester exchanges at the following foreign institutions:

## VII. <u>Visiting Scholars and Researchers Program</u>

The Center for International and Comparative Law hosts distinguished international academics, lawyers, judges, government officials, and graduate law students engaged in legal research and professional development. Such scholars and researchers visit SLU LAW for periods ranging from 10 days to one year.

Recent visiting scholars and researchers have come from diverse countries such as China, Germany, Italy, Portugal, and France. Over the years, visiting scholars and researchers have contributed to SLU LAW's rich intellectual climate while drawing on the wide-ranging expertise of SLU LAW's faculty in U.S. domestic, international, and comparative law.

#### VIII. LL.M. in American Law for Foreign Lawyers

The Center for International and Comparative Law offers a one-year LL.M. in American Law for Foreign Lawyers degree program. Students may choose to focus their course of study in a specialized area or pursue a general course of study. A Center faculty member serves as the program director, upholding the quality of the program and representing the interests of the students, as needed.

#### IX. Two-Year J.D. for Foreign Lawyers

The Center for International and Comparative Law offers a Two-Year J.D. for Foreign Lawyers degree program. This program allows well-qualified graduates of foreign law schools the opportunity to enter the J.D. program with advanced standing and to complete the J.D. within two academic years. A Center faculty member serves as the program director, upholding the quality of the program and representing the interests of the students, as needed.
