#### 5. Terms and Conditions of Agreement

Saint Louis University Libraries accepts the PROPERTY (and, if applicable, intellectual property) described above according to the following terms and conditions:

- a.) By execution of this agreement, the DONOR expressly represents and warrants that he/she is the sole lawful owner of title to the PROPERTY, or is the representative of the lawful owner, and is empowered to enter into this agreement.
- b.) The DONOR further represents that the PROPERTY is free and clear from any and all encumbrances, that there has been no prior pledge, option, or gift of any part thereof to any person, and that the DONOR has the right to give or transfer the PROPERTY.
- c.) The DONOR acknowledges that upon execution of this agreement, the PROPERTY irrevocably becomes the property of Saint Louis University Libraries. The display, use, maintenance, and disposition of the PROPERTY are at the sole discretion of Saint Louis University Libraries.
- d.) The DONOR represents and warrants that no customs laws, tax laws, laws of inheritance, or other laws or regulations applicable to the PROPERTY, or its export or import, have been broken.
- e.) The DONOR represents and warrants that there are no claims, judgments, liens, or other encumbrances of any kind whatsoever against the PROPERTY, and portion of the PROPERTY, or title to it.
- f.) The Internal Revenue Service has determined that Saint Louis University Libraries is organized and operated exclusively for educational purposes and is exempt from federal income tax pursuant to Section 501(a) and (c)(3) of the Internal Revenue Code. Saint Louis University Libraries does not advise donors on tax matters and suggests that the DONOR

direct any questions regarding donations as charitable contributions to the DONOR's tax advisor or an office of the Internal Revenue Office. Saint Louis University Libraries does not appraise donations.

g.) The DONOR will defend, indemnify, and hold Saint Louis University Libraries harmless from claims or allegations arising from or relating to conduct that would constitute a breach of the Donor's warranties or representations herein as established.
