Missouri Expungement 101

This free training will provide information on how to apply for an expungement of adult records or sealing of juvenile records in Missouri. Students who attend will be educated on the existing juvenile laws related to sealing juvenile records and why this could be important for a young person, as well as the new Missouri expungement law that takes effect Jan. 1, and they also will be trained in how to apply in criminal court. This training will prepare interested students to potentially assist youth in free clinics or workshops in partnership with the Juvenile Re-entry Assistance Program next semester. Juvenile sealing will be addressed from 1pm – 2:30pm, and expungement of adult records from 2:45pm – 5pm. [No RSVP required.](#)
