Criteria Sister Mary Teresa Noth Undergraduate Award Nominations

The Sister Mary Teresa Noth Awards are designed to acknowledge those undergraduate students or new graduates from all Saint Louis University School of Nursing undergraduate programs who have demonstrated excellence, academically and clinically. Recipients will be limited to no more than one from each undergraduate program (traditional, accelerated, and RN options).

Nominees for these undergraduate awards must be Chapter members or be eligible for Chapter membership and enrolled in an undergraduate program at Saint Louis University School of Nursing. Upon acceptance into the chapter, their nomination for an award will be considered with all others. Chapter members and eligible persons, who have graduated since the presentation of the previous year's awards, may also be considered.

To be eligible for award consideration, the nominee must be recommended by two Chapter members, or recommended by one Chapter member and endorsed by a second Chapter member. One of these members must be a Saint Louis University School of Nursing faculty member who has been involved in the nominee's clinical laboratory experience.

Selection of the award recipients will be based on the following criteria:

- 1. A cumulative GPA of 3.50.
- 2. Demonstrated excellence in four of the following areas:
 - A. Application of theoretical knowledge.
 - B. Provision of holistic and compassionate care.
 - C. Leadership
 - D. Application of nursing research or participation in nursing research.
 - E. Provision of professional, community, or University service

This undergraduate award will be presented to the nominees who best meet the above criteria.
