1. Which program student learning outcomes were assessed in this annual assessment cycle?

The program was launched in Fall 2017 and is still small, though slowly growing. In AY 2017-18, significant revisions were made to the originally approved (2014-15) program and approved by the Undergraduate Curriculum Committee of the College of Arts and Sciences; in AY 2018-19, added revisions were made and approved by the same committee. While overhauling the program in this way during the past two years, it was also necessary to overhaul the assessment plan. Steve Schoenig, S.J., director of undergraduate studies, reviewed feedback from the University Assessment Committee from Spring 2018, and worked closely with Kathleen Thatcher to develop new learning outcomes (see attached text below). By early Fall 2019, he will work with Kathleen to complete the assessment plan by clarifying assessment mapping, assessment methods, and the use of assessment data, so that the coming year can get underway with a revised and improved curriculum, learning outcomes, and assessment plan.

Because of the overhaul process outlined above, as well as the small size of the program, there has been little opportunity to make any meaningful assessment so far. In AY 2019-20, however, with all the necessary preliminaries in place, it is hoped that real assessment can begin.
