1. Which program learning outcomes were assessed in this annual assessment cycle?

Our accrediting body (LCME) found that our definition of, monitoring, and feedback of the required clinical experiences of our third-year students was unsatisfactory. This was an area for review and revision of process and procedure to ensure that outcomes (required experiences for students) were achieved across all seven clerkships. This year we took a closer look at our data collection and analysis of that data.

LCME Standard 6.2 Required Clinical Experiences. 3. How did you analyze the assessment data? What was the process? Who was involved?

Students enter the information about their required experiences in OASIS: a minimum number of patient types/clinical conditions and a minimum level or responsibility are set in the program, however students can exceed these limits and are encouraged to do so. Data are collected in OASIS (Online Access to Student Information and Scheduling), a software program that is utilized for many aspects of the MD program. The data collected are collated and presented in Tableau: for each of the seven core clerkships, we can

- verify that students are completing these requirements
- identify how they are completing the requirements (inpatient, outpatient, etc.)
- identify how many patients/conditions students see
- identify the level or responsibility (both student and physician)

Data on the required experiences are reviewed by individual clerkship directors during the course of each rotation, as well as during Clinical Curriculum Subcommittee meetings. The Associate Dean for Clinical Curriculum also monitors the process and works with the clerkship directors to ensure compliance with this LCME requirement.

4. What did you learn from the data? Summarize the major findings of your analysis for each assessed outcome.

Students are completing their requirement clinical experiences and achieving the objectives for this process: in doing so, they use a variety of instructional methods and resources. The patient types and conditions provide students with the experience/exposure they need to successfully complete each of the core clerkships. Where the expectation is that students are observed by faculty and/or residents, our faculty and housestaff are fulfilling their responsibilities for teaching.

5. How did your analysis inform meaningful change? How did you use the analyzed data to make or implement recommendations for change in pedagogy, curriculum design, or your assessment plan?

The outcomes were defined by the faculty and are specified in the required experiences. These data are collected do not identify outcomes, but rather ensure that outcomes are being met. The data analysis is not intended to inform curriculum design or assessment. The required clinical experiences for each clerkship are one aspect of our curriculum that is evaluated through other forms of assessment (objective structured clinical skills exams, NBME subject exams, etc.)

6. Did you follow up ("close the loop") on past assessment work? If so, what did you learn?

The mapping of our educational program objectives (EPOs) to course objectives and outcome measures, as reported last year has been very helpful in keeping us on-track to achieve our EPOs. This year we have begun adding another layer to this map-- the Entrustable Professional Activities for Entering Residency (EPAs). This addition will help identify new outcome measures and outcomes based on clinical practice to ensure that our students are, in fact, ready to begin their residency programs.
